Delegates and Presidents Meeting

May 1, 2023

via ZOOM

The Annual Spring Conference Delegates and Presidents was conducted by Zoom and recorded.

Governor Roxanne Aaron welcomed the conference delegates and declared Central East Coast Region's 5th Spring Conference to be in session on 5/1/23 at 7 PM.

Governor Roxanne presented the CECR Board Members, the CECR Parliamentarian, and the CECR's SIA Federation Visitor.

Governor Roxanne stated that region procedures allow for the appointment of a parliamentarian to oversee the conference and to keep the meetings flowing in an orderly manner.

Governor Roxanne announced that Paulette Evans, SI/Wake Forest has been appointed as Parliamentarian to assist with keeping the Conference in order.

Paulette stated that Standing Rules are included in the Call to Conference. A link to the document would be available in the Zoom chat.

Governor Roxanne requested Governor-Elect Robin provide a Preliminary Credentials Report.

Robin stated that 11 out of 17 Clubs in the Region are represented are on the call. For the purpose of quorum there are 11 out of 17 Clubs constitutes quorum.

Governor Roxanne asked Deb Mackes to present the Official Call to Conference.

Deb announced that in accordance with the Region Bylaws, the Official Call to Conference was emailed to all members of the Region who have a valid email address on record with SIA and also to CECR guests on March 17. This was 30 days in advance of the Conference. Deb announced that we would dispense with the reading of the Official Call to Conference, and that a link to the document would be available in the Zoom chat.

Governor Roxanne asked that Deb present the Minutes of CECR's 4th Spring Conference.

Deb announced that the Minutes of CECR 4th Spring Conference were prepared and included in the Call to Conference and asked if there were any questions or comments. Hearing none, Deb stated that the Minutes of CECR's 4th Spring Conference would be put on the consent agenda. The Consent Agenda will be voted on for approval at Conference on Saturday moring.

Deb stated the names of the three club members who agreed to serve as a committee to approve the minutes of the 5th CECR Conference would be: Pat Lynch, SI/Raleigh, Mary Harrison, SI/Woodbridge, and Debbie Blair, SI/Upper Montgomery County.

Governor Roxanne asked Treasurer Carolyn Skowron to present CECR's Financial Report.

Treasurer Carolyn reported that the Region is financially solvent. The Financial Report is included in the Call to Conference and a link to this documentation was made available in the Zoom chat for all to reference.

Treasurer Carolyn asked that the Financial Report be included in the Consent Agenda for approval during the business meeting at Spring Conference on Saturday morning, so it can be filed for audit.

In addition to presenting the financials, Treasurer Carolyn also reminded attendees of club financial obligations.

Region dues (\$25.00 per club member) are due to be paid 7/1/23 to Treasurer Carolyn, and can be paid by check, credit card, or a link on the website, and the needed information would be on the invoice that will be sent to all club treasurers

SIA Federation dues are also due to be paid by 7/1/23 to SIA.

The breakdown of SIA member dues will be shared with club treasurers when Treasurer Carolyn receives the information from SIA.

Form 200 should be submitted to Treasurer Carolyn when dues are submitted even if there are no changes in the listed officers. In addition to the names of club presidents and treasurers, Form 200 should also include the names and contact information for LYD chairs and club DIBI chairs.

Nominating Committee

Governor Roxanne shared the candidates for the Nominating Committee for the 2024-2026 Biennium who must be voted on at Spring Conference. Governor Roxanne announced the three candidates and read their bios: Kerry Ardner SI/Fairfax, Kathy Brinsfield SI/Salisbury, and Patricia Green SI/Montgomery County. This information is also included in the Call to Conference. Governor Roxanne asked if there were any nominations from the floor. There were none at this time.

The Nominating Committee will seek leads and nominations of potential candidates for five (5) CECR positions open for the 2024-2026 Biennium:

Governor-elect (1 position)

Secretary (1 position)

Treasurer (1 position)

Board Member-at-large (2 positions)

The 6th member of the CECR 2004-2006 Board, which is Governor-elect Robin Davis, SI/Woodbridge, VA, who was pre-elected and will automatically move to the position of CECR's 2024-2026 Governor.

Governor Roxanne asked, Deb Mackes of SI/Manassas, CECR Bylaws and Resolutions Chair, to explain the highlights of the proposed amendments to the bylaws and resolutions and the rationale for the changes.

Deb explained the proposals are intended to update Region Bylaws to coincide with SIA and are included in the Call to Conference. A copy of the Bylaws was sent to all Clubs with a request for input. Highlights of the proposed changes include:

Officers

Article 4.2 To be eligible for election to office, to include candidates who have served on their Club Board as President-Elect, Vice President, Treasurer, Secretary, or Board Director. A candidate who served as President of their Club would have preference.

Article 4.3 The Governor and Governor-Elect may hold office only for one term consecutively.

Article 4.4 In the case of a vacancy in the office of Governor, when the Governor-Elect automatically becomes the Governor to complete the unexpired term, A new Governor-Elect shall be solicited from the Region membership and the Region Board shall serve as the Nominating Committee. An election for the Governor-Elect shall take place within 90 days of the vacancy.

Elections

Article 5.2 If an emergency prevents holding of a conference, the CECR Board and the Nominating Committee shall determine the procedure for election of officers by mail or electronic means, conforming as nearly as possible to requirements of the Bylaws of the CECR.

Finance

Article 9.4 In the event of an emergency or disaster, the CECR Board may, by a two-thirds vote, waive, postpone, or reduce the CECR obligations of the club or clubs affected.

Governor Roxanne asked Governor-elect Robin Davis, SI/Woodbridge for a few words about Spring Conference in North Carolina. Robin shared highlights planned for Spring Conference to include a trolley ride through downtown Ashville, Embracing Dreams Dessert Social, networking activities, and some surprises, generating excitement for the upcoming conference.

Governor Roxanne asked if there were any further items to be discussed. Hearing none, the meeting was adjourned.

Governor Roxanne thanked everyone for attending tonight's meeting and said she looked forward to seeing everyone in person on Saturday, May 6.

Minutes of Central East Coast Region 5th Spring Conference

Friday, May 5, 2023

The Region began Spring Conference with an optional Trolley Ride through Ashville and a Dessert Social. This is the first in-person conference in three years due to the pandemic.

Saturday, May 6, 2023

Following the parade of current CECR Club Presidents and CECR Board of Directors, Governor Roxanne Aaron called the Conference called the meeting to order and welcomed members and guests to the inperson Spring Conference.

Governor Roxanne also recognized Kim Roney, the City of Asheville Councilwoman and Kymberelie Adams, SIA Headquarters Staff who were present for the business meeting. Governor Roxanne then asked Secretary Heather Jankovich to present official greetings. Secretary Heather summarized greetings from Michelle Burnett, Executive Director/CEO and Stephanie Smith, 2022-2023 SIA President.

Tara Ayers, President of SI/Wake Forest provided the inspiration for the day. President Tara shared The Starfish Story.

Board Member Jamilah Dalton asked that all those attending this year's spring conference as a first-time spring conference attendee come forward and be recognized. First-timers were presented with a gift and learned the privileges associated therewith.

Board Member Jamilah then asked Soroptimists with 30 or more years of membership to come forward. Each woman shared her name, club affiliation, and years of membership. After each member received a

token of appreciation. Treasurer Carolyn then came to the podium and shared the total years of service of these seasoned attendees which was 440 years!

Program Chair, Ginny Dempsey, introduced Kim Roney, the City of Asheville Councilwoman. Ms Roney presented a proclamation from the Mayor of Asheville welcoming Soroptimists to the city. Governor Roxanne then presented Ms Roney with a gift.

Governor-Elect Robin presented the preliminary and secondary credentials reports. It was moved and seconded that the credentials reports be adopted.

Governor Roxanne announced her appointment of Paulette Evans, SI/Wake Forest to serve as the parliamentarian for spring conference.

Board Member Wilma moved that the agenda for Spring Conference be approved, with any modifications as may be needed to carry out the business of the region. The motion was seconded and approved.

Secretary Heather presented the items on the Consent Agenda for voting by delegates. She explained the consent agenda process discussed in the Delegates Meeting on May 1st via ZOOM. The Consent Agenda streamlines meeting procedures by collecting routine, non-controversial items into a group whereby all are passed as a single motion and vote. The intention is for this new procedure to allow additional time for workshops and presentations.

Included in this year's Consent Agenda are the Minutes of the 2022 Spring Conference and the Region financial reports. Additionally, Kerri Ardner of SI/Fairfax has been nominated to join Cathy Brinsfield of SI/Salisbury (appointed by Governor Roxanne) and Patricia Green of SI/Montgomery County (appointed by the CECR Board) on the CECR Nominating Committee for the next biennium in which Governor-Elect Robin will serve the Region as Governor.

A motion was made, seconded, and approved for the Consent Agenda to be accepted. Governor Roxanne congratulated and introduced the Nominating Committee. Governor Roxanne appointed Kerri Ardner as the nominating committee chair.

Governor Roxanne further announced and introduced the members who agreed to serve as the committee to approve the minutes of the 5th Regional Conference: Pat Lynch, SI/Raleigh, Mary Harrison, SI/Woodbridge, and Debbie Blair, SI/Upper Montgomery County.

Parliamentarian Paulette moved to adopt the changes to the CECR Bylaws as presented at the CECR Caucus on May 1. The motion was seconded and approved.

Board Member Wilma introduced Federation Guest, Vivian. Federation Guest Vivian gave the Federation Report and allowed time for a question-and-answer session.

Following an explanation of the process of the workshops, Governor Roxanne adjourned the meeting for attendees to attend workshops.

Live Your Dream Awards Presentations

Governor Roxanne invited Live Your Dream Chair, Terri Craig SI/Raleigh, to share information about the program and announce the winners of the CECR Live Your Dreams Awards.

Terri explained that 16 of our 17 Clubs participated in the LYD Program. In 2023, our Clubs awarded a total of \$56,300 to 45 deserving women. This was a 25% increase in the number or awards and 24% increase in dollars awarded compared to 2022.

Each Club submitted its top recipient to the Region for consideration of an additional award. The Region granted a total of \$12,000 to 6 LYD Award recipients across the Region. These women were recognized at Spring Conference with two of four \$1,000 CECR LYD Award recipients sharing their story via video.

Our top recipients, Shashawna and Erica, joined us in person at the conference. They shared a little more of their stories and how much the award meant to them. They each thanked Soroptimist for the opportunity to continue their education and achieve their dreams. Shashawna received \$3,000 and Erica received \$5,000.
